Oniro Coated Lava retails at EGP 5 per pack, a new price point within the segment. The new launch is in line with Edita's strategy to diversify its product portfolio and cater to its customer's evolving tastes and preferences.





Edita first entered the biscuit market in 2020 with the launch of its 10th brand Oniro. Through the launch of new SKUs, Edita aims to widen its product offering and capture a larger share of the biscuit market, which is valued at approximately EGP 6 billion.

The Company holds strong number-one market positions in its core cake and bakery segments as well as in rusks, a leading market position in candy and a growing market position in the wafers segment.
