



<sup>\*</sup>According to the text of Article (21) of the company's articles of association, the company is managed by a board of directors consisting of (thirteen members at least and nineteen members at most) appointed by the general assembly, and each of them is required to be the owner of a number of company shares whose value is not less than a quarter of a million dollars, and it is permissible to include two or more experienced members who do not have ownership of shares, and the current board was elected by a decision of the company's ordinary general assembly, which was held on Thursday, 30/3/2023, and the company's share price reached the Egyptian Stock Exchange according to the last session before the date of the aforementioned assembly was \$1.233, and accordingly, the membership guarantee shares for each board member amounted to 202,758 shares, and therefore the board membership guarantee shares for 14 board members amounted to 2,838,612 shares.


