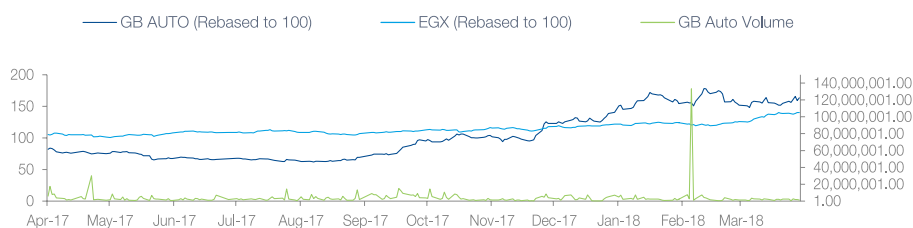

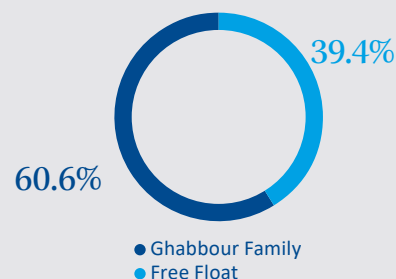

(AS OF 30 JUNE 2018)



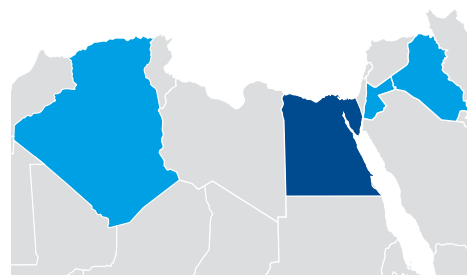
