The Cairo Regional Center for International Commercial Arbitration certifies that Abdul Kadir Al Muhaidab and Sons has submitted an arbitration notice on 13 February 2020 against:

And the case was registered under No. 1394 of 2020 and is still considered before the arbitration tribunal.

The closing requests by the claimant, as stated in the memorandum of reply dated 25 March 2021, were as follows:

- Issuing a decision stating that the Claimant Company is the legal owner of 49% of Al Mokhtabar's Share and deciding on the specific performance to enable the Claimant Company to pay the amount of 41 million Egyptian Pounds for:
  - a) Having the right to ownership of 49% of Al Mokhtabar;
  - b) Having the dividends for profit share distributed by Al Mokhtabar since October 2007 until the date of issuance of the arbitration decision.
- Alternatively, if the arbitration tribunal decides on the impossibility of specific performance, compelling the Respondents to jointly and in solidarity to pay to the Claimant a compensation in the amount of USD 145,806,360 (one hundred and forty five million and eight hundred and six thousand and three hundred and sixty United States Dollars).
- Compelling the Respondents to pay an interest at the rate of 5% on the awarded amounts from the date of the award until full payment.

- Deciding that the Respondents shall, individually and in solidarity, bear the full costs of the arbitration and all previous legal actions, including the administrative costs of the Centre, and costs and fees of the arbitration tribunal, attorney fees, costs and expenses, court fees and compensation for the time spent by the Claimant in litigation for the requests made in this arbitration case.

This certificate was issued on 28 April 2021 upon the request of the Claimant's attorney without any liability on the part of the Centre.
