

# إتمام الطرح العام لثروة كابيتال القابضة بنجاح وتغطية الإكتتاب بأكثر من ٣٠ مرة وبدء التداول في ١٥ أكتوبر تحت رمز SRWA.CA

## القاهرة في ١١ أكتوبر ٢٠١٨

أعلنت اليوم شركة ثروة كابيتال القابضة للإستثمارات المالية ش.م.م. ("ثروة كابيتال" أو "الشركة")، الشركة الرائدة في الحلول والخدمات التمويلية في مصر، عن غلق باب الإكتتاب في شريحة الطرح العام والمكون من ٢٩,٥١٧,٠٧٣ سهم من أسهم رأس مال الشركة.

ومن المقرر أن يبدأ التداول إعتباراً من يوم الإثنين الموافق ١٥ أكتوبر ٢٠١٨ تحت رمز SRWA.CA عقب موافقة البورصة المصرية. ويخضع الطرح العام إلى حساب دعم إستقرار سعر السهم والمخصص للمشتركين في الطرح العام خلال فترة مدتها شهر من تاريخ بدء التداول كما هو وارد بنشرة الطرح.

علماً بأنه تم تنفيذ عملية الطرح على شريحتين: الشريحة الأولى طرحت للإكتتاب العام للجمهور من الأفراد الطبيعيين والإعتباريين لعدد ٢٩,٥١٧,٠٧٣ سهم تمثل نسبة ١٠٪ من عدد الأسهم المطروحة للبيع، والشريحة الثانية طرح خاص للمستثمرين من المؤسسات المالية والأفراد ذوي الملاءة المالية والأفراد والجهات ذوي الخبرة في مجال الأوراق المالية لعدد ٢٦٥,٦٥٣,٦٥٨ سهم تمثل نسبة ٩٠٪ من عدد الأسهم المطروحة للبيع. ومن الجدير بالذكر أنه سيتم تخصيص مبلغ ٧٠٠ مليون جنيه من حصيلة الطرحين العام والخاص لزيادة رأس مال الشركة في زيادة مغلقة مقتصرة على المساهمين البائعين بما يعادل عدد ٩٥,١٠٨,٦٩٦ أسهم.
